INTRODUCTION

The Construction Education and Training Authority (CETA) is a Schedule 3A Public Entity established in terms of the Skills Development Act, No.97 of 1998. It exists primarily to facilitate training and skills development in the construction sector within the context of the National Qualifications Framework (NQF).

SCOPE OF WORK/DELIVERABLES

CETA needs to appoint a service provider that will be responsible for the monitoring and evaluation of CETA Accredited Training Providers.

Service provider must meet the following requirements:

- Monitoring and evaluation of private and public providers, learning sites, as well as learnerships, skills programmes and other learning pathways.
- Focus on Accreditation of training providers in line with the requirements and the delivery of accredited programmes, the estimated number of Providers is 503.
- Quality Assurance of the training of the Learners towards Achievements.
- Data gathering and formulation of Monitoring and Evaluation criteria and indicators.
- Determination of provider and programme strengths and weaknesses.
- Determination of development, empowerment and support needs of providers, including employers providing workplace training.
- Analysis of general compliance with quality assurance requirements.
- Development of Monitoring and Evaluation instruments.
- Consultation with relevant provider representative bodies.
- Transfer of skills to relevant CETA staff.
- Writing of project report, including recommendations.

The successful Service provider will be expected to submit a detailed report to CETA on a monthly basis on all services carried out during the months and consolidated quarterly reports for the 4 quarters.

EVALUATION CRITERIA

Criterion 1 – Compulsory Requirements

Bidders will first be evaluated in terms of the gatekeeper/minimum requirements on page 2 of this document. Bidders who do not fulfil all the requirements or do not submit the required documents will be disqualified. Those who fulfil all the requirements or have submitted the required documents will be further evaluated on functionality.

Criterion 2 – Functionality

Functionality is worth 100 points. The minimum threshold is 70 points. Bidders who score less than 70 points on functionality will therefore be disqualified. Those who score more than 70 points will be further evaluated in terms of price and preference points (i.e. on the B-BBEE status level of contributor). 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (j) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
